2026.52 Village Green Grass Cutting

To receive updates on the cutting of grass on the Village Green and the transfer from ERYC to a local contractor.

The Clerk had arranged for the Parish Council to leave the existing arrangement with ERYC for grass cutting on the Village Green. This would happen with immediate effect, and ERYC had also agreed to waive the charge for the initial cut on Monday 18th May 2026.

The local contractor had completed two cuts to date, with one or more further cuts to be made in readiness for the Village Fete at the beginning of August.

2026.53 Parish Matters

Cleaning of the village pond has been included as part of the application to the "Do It For East Yorkshire" grant scheme

An application has been completed and submitted, incorporating cleaning of the village pond together with the addition of new plants, aeration equipment and landscaping materials. An information board is also planned, and there will be regular water testing to prevent a repeat of the previous issues with water quality

The outcome of the application is awaited, with works to commence as soon as possible

(c) To receive an update on the Community Speed Watch scheme

Cllr Pearson provided the following update;

- five potential sites have been identified around the village, with the intention to try each of the sites once to assess their suitability
- a national day of action is planned for Wednesday 15th July, but both Fridaythorpe and Wetwang will be unable to take part due to a lack of available volunteers
- two sessions had been held so far, with each taking place between 6:00pm and 7:00pm
On Thursday 25th June 159 vehicles were tracked, with 11 vehicles found to be exceeding 30mph and a highest recorded speed of 48mph
On Monday 6th July a further 159 vehicles were tracked, with none found to be exceeding 30mph and a highest recorded speed of 29mph
